1. Introduction

4.3. **Patients/Service Users**: Patients and service users are encouraged to report any safeguarding concerns they may have to MAST & SENDAC staff. They should be assured that their concerns will be taken seriously and handled confidentially.

5. Identifying and Responding to Safeguarding Concerns

5.1. **Recognition**: MAST & SENDAC staff should be vigilant and knowledgeable about the signs and indicators of abuse or neglect. This includes any unusual behaviour, physical injuries, emotional distress, or changes in a patient's condition.

5.2. **Reporting**: Any staff member who has reasonable grounds to suspect or believes that a patient or service user is at risk of harm, abuse, or neglect must report their concerns to the designated safeguarding lead within MAST & SENDAC.

5.3. **Confidentiality**: All safeguarding concerns will be handled with the utmost confidentiality. Information will be shared only on a need-to-know basis and in compliance with relevant laws.

6.1. **Risk Assessment**: MAST & SENDAC will conduct risk assessments to identify vulnerable individuals and potential risks within our services.

6.2. **Communication**: MAST & SENDAC will ensure open communication with relevant external agencies and authorities as required by law to address safeguarding concerns.

6.3. **Training**: MAST & SENDAC will provide ongoing training to staff on safeguarding protocols and procedures, ensuring they are up to date with the latest guidance.

6.4. **Support**: MAST & SENDAC will provide support to individuals who have experienced harm, abuse, or neglect and facilitate their access to appropriate services.
